Because of the potential benefits of equine assisted coaching, I hereby waive all rights, if any, claims, causes of action and lawsuits which the client or I may have against Cortney Rothman LLC its contracted personnel, employees, volunteers, family, heirs, executors, legal representatives, administrators, successors, assigns, guests, employees, or agents affiliated with any of them in any manner, and any equine professional operating on the property, as well as Community Horse Sanctuary, Silverwinds Training or Mountindale Barn owners, for any injury, liability or damages which may occur while interacting with any horse or participating in any activity involved with the handling or care of horses while involved in the equine assisted coaching program, unless caused by willful misconduct or gross negligence of the above mentioned providers of treatment.

I agree to indemnify, defend and hold harmless Cortney Rothman, Cortney Rothman Coaching LLC, Community Horse Sanctuary, Silverwinds Training or Mountindale Barn, or any person or entity whose land a horse-related activity occurs, for any accident, injury, death, or loss that might occur, and free such persons from all liability for such injury, death, or loss. I understand that interacting with horses always involves danger and I engage at my own risk. This release extends to all claims, whether presently known or unknown.

The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, participant and spectator. I hereby expressly waive any benefits I may have relating to the release of unknown claims.
